

Liberty Propane's 100 Gallon Giveaway Official Rules

Liberty Propane is awarding a prize consisting of one drawing for 100 gallons of propane. These rules apply to the 100 Gallon Drawing to be held on September 4, 2018, where customers can register at the Customer Appreciation Day Event being conducted by Liberty Propane on July 20, 2018.

1. Eligibility:

Contest is open to U.S. citizens or legal residents, age 18 or older who are existing, residential propane customers residing within the delivery area of Liberty Propane. This contest is void outside of Liberty Propane's serviceable area and where otherwise prohibited or restricted by law. Only one entry per household will be accepted. Employees (including, but not limited to consultants, independent contractors, and interns) of Liberty Propane, or its subsidiaries and members of their Households are not eligible to participate.

All entries must be received by conclusion of business on Friday, August 31, 2018. Drawing will be held on or around Tuesday, September 4, 2018.

4. Prizes:

One winner will be determined by a random drawing to be held of all eligible entries on Tuesday, September 4, 2018. The winner will be notified within 24 hours of the 100 gallons of propane drawing (on or about September 4th, 2018). Winner will be required to respond to the e-mail or phone call to acknowledge receipt of the prize.

5. Odds of Winning:

Only one Prize will be awarded. Each entrant's odds of winning depend on the number of entries received.
